Interesting Article

You probably have your own personal list of travel musts-haves — items that you always want with you when going on a trip. Mine include a travel packet of wipes, moisturizer with sun screen, essential meds plus prescriptions *just in case*, and my international service-enabled cell phone plus charger. There are other items on my list, but these items always go into my carry-on bag first.

But there are also items that should be included on every traveler's list, no matter who you are or where you're going. Similarly, there are certain items that, for the most part, aren't worth the space they take up in your suitcase.

Today I want to share my list of top 10 must-haves for international travel, and I'll follow it up shortly with items that you can afford to leave at home.

- Medication. You should always carry all of your prescription medication in your carry-on bag, not in your checked luggage. I find the containers that are marked with the days of the week to be the most helpful. Fill them up so that you have all the pills you need per day in each little container. If you need more than a week's worth, fill up a second container. Ziplock bags make for perfect storage for these handy containers. If one of the compartments should open, the pills fall harmlessly into the plastic bag, safe and clean. Also, I recommend carrying a small assortment of other medication, including those to treat a cold, sore throat, or upset stomach. Even if you're not sick when you leave, it's better to have medication with you should something happen while away.
- BE PREPARED: Pack your medication according to the days of the week for easy access on your
 vacation Photocopies of your passport. It's never fun to lose your passport, but the
 experience can be somewhat less frustrating if you keep a paper copy of it with you. You
 won't be able to use the copy to get through security, but it will be very helpful when you go
 to the closest U.S. consulate to get a new one. Just be sure to keep the copy somewhere
 separate from your real passport, so you have less of a chance of losing both!

- Eyewear. Here is where it pays to exaggerate. If you wear contacts, remember contact lens
 solution, a case or two, and plenty of spare lenses should you rip or lose your primary pair.
 If you wear glasses, pack a back-up pair as well as a small eyeglass repair kit, which can be
 found in most drugstores and supermarkets. Finally, even if you have perfect vision, be sure
 to pack sunglasses to protect your eye
- Phone charger. Unless you have an international plan for your cell phone, you probably won't be
 able to make calls for the majority of your trip. But many of us use our phones as our camera
 or music player, so be sure to bring along your charger. Even if your family and friends are
 already on your phone contact list, it's helpful to tuck a paper list of family and friends'
 telephone numbers in with your other travel documents so you (or others) can contact them
 if necessary.
- Inflatable neck pillow. Inflatable neck pillows are handy to have on a long flight or bus rides. Just blow them up and settle in for a light snooze, then deflate them for easy transportation in your purse or bag. They can help you feel refreshed and avoid neck pain that can put a damper on your vacation.
- MUST-HAVES: Remember space-saver bags, ear plugs, and a neck pillow for comfortable traveling Ear plugs. Who would guess that these small items would be such a lifesaver while traveling? They're an absolute must-have and can be used almost anywhere – from the plane to the hotel to the bus you'll probably be traveling on. I always carry extra earplugs as well in case my seatmate needs a pair – it's a great way to make friends on a noisy plane or bus ride.
- Your camera and accessories. Toting your camera, charger or batteries, and extra memory cards is
 necessary for collecting ample photo documentation of your trip. The extra memory cards
 are an absolute must, because they take up very little space physically, yet allow you to
 capture so many memories that you'll treasure for years to come.
- Voltage converter and plug adapter. To plug your phone or camera charger in overseas, you'll
 need a voltage converter and plug adapter to work in their outlets. You can pick up a good
 converter kit at an electronics store or on <u>Amazon.com</u>. A good model will cost about \$25 or
 less, so it's definitely worth the investment, and new versions are compact and easy to pack.
- Poncho or travel umbrella. This suggestion is especially relevant for those who plan on taking excursions, such as sightseeing, hiking, or biking, during their trip. Packing a poncho or travel umbrella could end up being a lifesaver if you encounter bad weather but still want to enjoy the great outdoors. You can pick up a very lightweight but effective plastic poncho at any dollar store for, you guessed it, a dollar!

PARTICIPANT RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT. Please read and be certain you understand the implications of signing.

Express Assumption of Risk Associated with Sport, Venue Use and Related Activities.

- Risk of injury from the activity and equipment utilized is significant including the potential for broken bones, severe injuries to the head, neck, and back or other bodily injuries that my result in permanent disability and death.
- 2. Possible equipment failure and/or malfunction or misuse of my own or others' equipment.
- I AGREE THAT I WILL WEAR APPROVED PROTECTIVE GEAR AS DECREED BY THE GOVERNING BODY OF THE SPORT I AM PARTICIPATING IN. However, protective gear cannot guarantee the participant's safety. I further agree that no helmet can protect the wearer against all potential head injuries or prevent injury to the wearer's face, neck or spinal cord.
- 4. Variation and/or steepness of terrain, variation or changes in surfaces including but not limited to snow surfaces, ice, bare spots, rocks, stumps, debris, cliffs, trees, fences, posts, trees, light poles, signs, buildings, roads, walkways, ramps, rails, stairs, pyramids, manual pads, bowls, half-pipes, jumps, padded and non-padded barriers, other persons, and other natural and man-made hazards.
- My own negligence and/or the negligence of others, including but not limited to operator error and guide decision making including misjudging terrain, weather, riding surfaces or other obstacles.
- 6. Exposure to the elements and temperature extremes may result if frost nip, frost bite, heat exhaustion, heat stroke, sunburn, hypothermia and dehydration.
- Dangers associated with exposure to natural elements include but are not limited to avalanche, rock fall, inclement weather, thunder and lighting, severe and or varied wind, temperature and other weather conditions.
- 8. Accidents or illness occurring in remote places where there are no available medical facilities.
- 9. Fatigue, exhaustion, chill, and/or dizziness, which may diminish my/our reaction time and increase the risk of accident.
- Impact or collision with other athletes, spectators, facility employees, pedestrians, motor vehicles, and cyclists.

"I understand the description of these risks is not complete and unknown or unanticipated risks may result in injury, illness, or death.

WARNING

I am aware and acknowledge that racing and training and practice for racing have inherent dangers and risks for any competitor. Race courses may be icy, rutled, and bumpy. I assume the risk of all course conditions including, but not limited to weather and snow conditions, course construction or layout, and obstacles. I am required to inspect physically and visually the course and area of competition prior to the beginning of competition and, by using the course, assume the risk of all course conditions. I am voluntarily participating in these races and training and practice for the race with the full knowledge of the dangers and risks involved and hereby agree to accept any and all risks or injury, or death that my result.

Release of Liability, Waiver of Claims and Indemnity Agreement

In consideration for being permitted to participate in the above described activity(ies) and related activities, I hereby agree, acknowledge and appreciate that:

- I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE, the following named persons or entities, herein referred to as releasees: Bay Area Snow Sports Council (BAC) and their directors and officers; BAC Ski Clubs and their directors and officers; and their successors and assigns.
- 2. To release the releasees, their officers, directors, employees, representatives, agents, and volunteers from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the releasees or otherwise. BAC TRIP CONDUCT POLICY

This policy applies to all persons participating on a Bay Area Snow Sports (BAC) ski week or other trip. It is intended to maximize the enjoyment for all trip participants and provide guidelines for the BAC Travel Staff and assigned Trip Assistants. All trip participants are requested to observe common courtesy and generally accepted standards of social and moral behavior.

In accordance with Federal and State laws, BAC will enforce a "Zero Tolerance Policy" on illegal drug use at any BAC sponsored event or trip. Failure to observe this policy will automatically remove you from participation in future BAC events.

Participants shall adhere to the requirements of BAC trip packages (e.g., lift tickets when offered) and participants agree not to transfer, resell, or barter all or portions of that package. Only BAC or the issuing agency may compensate the participant for the unused portion or permit transfer. Failure to comply may result in exclusion from future BAC events.

Alcohol and tobacco use is allowed in moderation and where permitted by law. BAC Travel Staff or assigned Trip Assistants, will ask a participant to cease any loud, obnoxious, or offensive behavior, should it occur. Participants who refuse to cooperate will be reported to local security or local police.

BAC maintains a strict policy prohibiting sexual harassment and harassment because of race, religion, color, national origin, ancestry, disability, medical condition, marital status, sexual orientation, age, or any other basis made unlawful by any applicable law or ordinance or regulation. Prohibited harassment in any form, including verbal, physical and visual conduct, threats, demands, and retaliation is unlawful and will not be tolerated. If, after a request to refrain from this behavior, the participant continues, BAC Travel Staff and assigned Trip Assistants may contact local security or local police. Profanity and off-color humor is only permitted if it is not offensive to other participants. Please stop the offensive behavior if asked by another participant, BAC Travel Staff or assigned Trip Assistant.

Parents/Legal Guardians of minor children under the age of 18 are responsible for the supervision and behavior of their children. Children under12 years will be under the direct supervision of their parents/legal guardians at all BAC events. Parents/Legal Guardians are responsible for providing supervision of their children under 12 years of age during the time that they are attending a BAC function without their children (e.g., children under 12 will not be left alone in the lodging rooms).

BAC Travel Staff, assigned Trip Assistants, and/or BAC Board of Directors will attempt to resolve problems in a mutually beneficial manner. When resolution cannot be achieved, BAC Travel Staff and assigned Trip Assistants have the authority to call on-site security or local police to resolve the problem. Participants may be excluded from a trip at their own expense and without reimbursement of trip expenses.



Visit the Church of St. Ilya the Prophet, an incredible structure filled with frescoes and classic Russian architecture, then wander the grounds of the Saviour - Transfiguration Monastery, one of the oldest along the Volga. The ship sails for Goritsy this afternoon. Meals: B, L, D

DAY 7 - Goritsy

The arrival to Goritsy brings you to a typical Russian village set in the most scenic countryside. Depart by coach to the Kirillo-Belozersky Monastery. Founded in 1397 by Cyril, one of the most honored saints in the Russian Orthodox Church, the monastery houses the Assumption Cathedral and many ancient icons which were loved by Ivan the Terrible. The ship departs for Kizhi Island early this afternoon. Meals: B, L, D

DAY 8 - Kizhi

Cruise Lake Onega, Europe's second largest lake, before arriving at the small island of Kizhi. Depart on a walking tour through the Open Air Museum of Architecture (a UN-ESCO World Heritage Site), housing a collection of restored 18th-century Russian wooden buildings. The highlight of the museum is the three-tiered, 22-domed Transfiguration Cathedral. Built in 1714, this amazing structure is constructed entirely without nails! Set sail for Mandrogi this evening. DAY 9 - Mandrogi

Visit the picturesque village of Mandrogi located on the River Svir. The charming landscape is dotted with colorful "izbas" – wooden houses with finely carved roofs and window frames. During your free time, visit the Vodka Museum or shop for local handicrafts such as pottery and the famous "matryioshka" dolls. An afternoon departure and leisurely cruise along the river ends the day. This evening, the Captain hosts a farewell reception. Meets: B, L, D

DAY 10 - St. Petersburg

Sailing on the Neva River, arrive in St. Petersburg this morning, and after breakfast, depart on a guided tour of this UNESCO World Heritage Site city. Travel along the Nevsky Prospect, the main boulevard of St. Petersburg, and pass the Gostiny Dvor (city's largest department store), the National Library, monument to Catherine the Great, the sights of the Church of the Savior on the Spilled Blood, the Kazan and Saint Isaac's Cathedral. 


